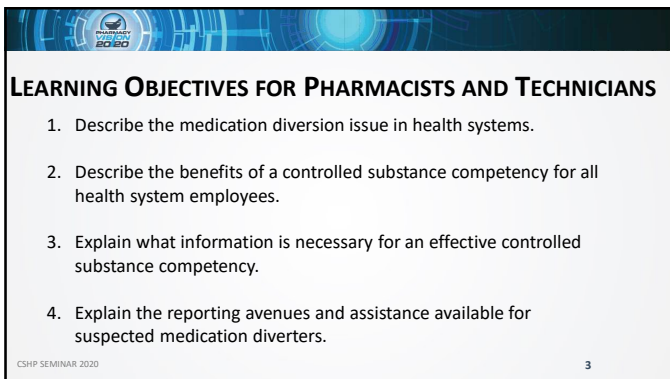

WHAT IS DRUG DIVERSION

- Drug diversion is the transfer of a prescription drug from a lawful to an unlawful channel of distribution or use.
- Challenged with alcohol and/or drug dependency among healthcare providers:
 - 15% of pharmacists
 - 10% of nurses
 - 8% of physicians

THE DRUG DIVERSION ISSUE

The United States Department of Health and Human Services (HHS) and the Disease Control and Prevention (CDC) report that opioids killed more than 42,000 people in 2016.

- 66% of drug overdose death involved an opioid
- 40% of all opioid overdose deaths involved a prescription opioid

THE OPIOID EPIDEMIC

The OPIOID EPIDEMIC by the number

IN 2016

- 116** people died every day from opioid-related drug overdoses
- 11.5 m** people misused prescription opioids*
- 42,249** people died from overdosing on opioids†
- 2.1 million** people live with opioid use disorder†
- 948,000** people had an opioid use disorder†
- 170,000** people started heroin for the first time
- 2.1 million** people misused prescription opioids for the first time†
- 17,087** deaths attributed to overdosing on commonly prescribed opioids
- 19,413** deaths attributed to overdosing on synthetic opioids other than methadone†
- 15,469** deaths attributed to overdosing on heroin†
- 504 billion** in economic losses in economic costs

DRUG DIVERSION IMPACTS ON PATIENTS

Patients seeking care may be harmed by varying types of healthcare workers who are drug diverters.

- Patients may suffer increased pain if their medications are diverted
- Infections spread via tampered injectable controlled substances

DRUG DIVERSION IMPACTS ON THE HEALTH SYSTEM

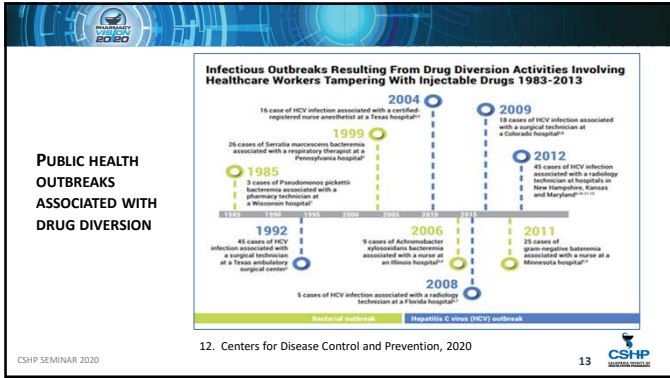
Many incidents of health workers diverting controlled substances have been reported in the news media and to regulatory agencies, resulting in large legal and regulatory penalties.

- September 2015 – Mass General \$2.3 Million
- May 2018 – Effingham Health System - \$4.1 Million
- August 2018 – University of Michigan \$4.3 Million

BENEFITS OF A COMPETENCY FOR ALL EMPLOYEES

All health systems that have controlled substances are faced with the reality of and need to safeguard against diversion. Thankfully, innovations by vendors, improved hospital policies, and increased security have improved the secure storage aspects of narcotics.


However, one critical area of diversion prevention that lacks attention is staff and nursing education regarding the recognition of diversion.





- Give basic descriptions of the methods without giving employees ideas
 - Taking the 'waste' for personal use
 - Stealing controlled substances from the patients
 - Tampering with patients-controlled substance medications

HOW TO RECOGNIZE AN IMPAIRED EMPLOYEE OR DIVERTER

- Increasing personal and professional isolation
- Personality change - mood swings, anxiety, depression
- Progressive deterioration in personal appearance and hygiene
- Heavy "wastage" of drugs
- Excessive amounts of time spent near a drug supply

HOW TO PREVENT DRUG DIVERSION


- Never leave controlled substances unattended.
- Secure and sign out of Pyxis when transaction is completed.
- Dispose of controlled substance waste properly, according to policy.
- Be aware of your surroundings always.
- Report any unusual and suspicious activity to your supervisor right away.

HOW TO DEAL WITH AN IMPAIRED OR DIVERTING EMPLOYEE


- If you recognize symptoms in a co-worker, demonstrate concern
- Encourage employee to seek drug treatment assistance.
- Your action could affect the safety and welfare of the employee AND those patients who encounter them.


