



10 Year Limited Warranty

Whereas subject to the terms and conditions herein, Basecrete Technologies LLC, henceforth referred to as Basecrete, warrants its product to be free of manufacturing defect and to not fail under normal usage for a period of 10 years from the date of purchase provided the product is used before the expiration date printed on the original container and also according to the written technical data sheets and instructions given with the product or found on our website, applicable building regulations and codes, and industry standard practices. The coverage warranty is limited to the original buyer of the product and is non-transferrable. Terms of this limited warranty are subordinate to the limitations, restrictions, and the exclusions set out as follows:

Exclusions from Warranty Coverage
