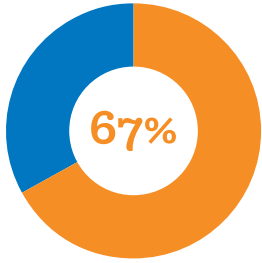


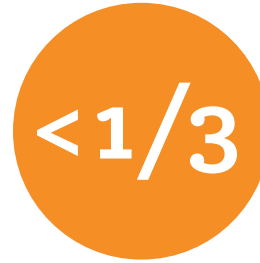

Approximately 67% of SNFs provide restorative nursing care programs.¹



However, fewer than 1/3 of long-stay residents participate in these programs with less than 10% of residents receiving care for 6 of 7 days² resulting in a missed clinical and financial opportunity.

Personalized Approach

Aegis' Restorative Care Program is a multi-disciplinary approach, including **therapy, wellness, nursing** and **activities**. This program focuses on what an individual can do and promotes the ability to adapt and adjust to living as independently and safely as possible as they transition to their next level of wellness.

The results on the right display the clinical and financial impact in a program representing 33 Medicaid residents over one quarter, before and after the implementation of a restorative care program.

In addition to the Medicaid opportunity shown here, there is a new opportunity that will present itself in a PDPM environment. The new nursing case mix category will include restorative services and will provide the opportunity to impact case mix rates in the behavioral, cognitive, and reduced physical function categories by 5% - 10% per patient per day. **This change results in an improved nursing case mix payment of up to \$15 dollars per patient per day.**

Restorative Model

In our service delivery model, Aegis hires and employs the restorative staff, provides all training and ensures effective execution of all aspects of the program.* Per CMS guidance, there must be a nursing supervisor on record who is a facility employee.

Collaborative Practice

Aegis firmly believes in the efficacy of collaboration between rehab and nursing services for handoff and carryover of care to sustain patients at their highest level. We will work with you to develop and train restorative programming to meet the needs of your residents, which may include ADLs, functional mobility, cognition or dining programs.

We utilize a standard approach for all members of the restorative team. Key elements include:

- Self-assessment
- Competency checklist
- Orientation and annual training
- Proficiency check off

Through orientation and annual training, restorative team members learn about PDPM requirements and receive a Medicare overview that includes restorative nursing and rehab collaboration. Aegis has a full Restorative Aide training manual and program that we use to train staff.

Aegis also has clinical support teams across the country that are trained in collaboration with providers in the state-specific details of the Medicaid Case Mix Index (CMI) process.
