

COVID-19 Disclaimer: Health and Safety Wavier

The attendee registering for the Society to Improve Diagnosis in Medicine (SIDM2022), 15th Annual Meeting is voluntarily signing this Waiver of Liability and Hold Harmless Agreement ("Agreement") considering the facts set forth below.

The state of medical knowledge continues to evolve, but there exists the potential for the virus to spread from person to person through contact or through the air. Also, it is possible for persons to be infected without symptoms and hence to spread COVID-19 without knowledge of infection. COVID-19 can cause serious and potentially life-threatening illnesses.

SIDM will comply with all recommendations and guidance concerning COVID-19 as set by Minneapolis, Minnesota CDC Guidelines. Based on the current state of medical knowledge, the attendee agrees and recognizes that there is no certain way for SIDM to eliminate the risk of the transmission of COVID-19 at the annual meeting.

ASSUMPTION OF THE RISK:

I have read and understand the above warning concerning COVID-19 and I hereby accept the risk of contracting COVID-19 in order to attend the SIDM2022 Annual Meeting. I understand, that given the current state of medical knowledge, that there is a risk that I may contract COVID-19 by attending the SIDM2022 Annual Meeting and, I could also spread COVID-19 to others including my family, friends, employers, and employees.

WAIVER OF LAWSUIT/LIABILITY:

I hereby forever release and waive my right to bring a lawsuit or any other type of action against SIDM and its officers, directors, managers, officials, trustees, agents, employees, attorneys, or other representatives in connection with attending the SIDM2022 Annual Meeting ("Released Persons"). I understand that this waiver means that I give up my right to bring any claims, including claims for personal injuries, death, disease or property losses, or any other types of losses, including but not limited to claims of negligence and to give up any claim that I have to seek damages whether known, unknown, foreseen, or unforeseen against the Released Persons.

HOLD HARMLESS AGREEMENT:

I agree to indemnify and hold the Released Persons harmless from any loss, liability, damage, or costs, including any attorney's fees and costs that may incur due to my participation at the SIDM2022 Annual Meeting. I further hereby release and agree to hold SIDM harmless from and waive on behalf of myself, my heirs, and any other SIDM participants from any causes of action, claims, demands, damages, costs, expenses, and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act, or that may otherwise arise in any way in connection with SIDM2022 Annual Conference.

COMPLETE AGREEMENT & SEVERABILITY CLAUSE:

This Agreement represents the complete understanding of the parties regarding these issues and no oral representations, statements or inducements have been made apart from this contract. Should any part of this Contract be deemed void or unenforceable, that provision shall be deemed to be severable from this Contract and it shall not affect the validity and enforceability of the rest of this wavier agreement.

PERSONAL RESPONSIBILITY:

I acknowledge and understand that I must comply with all set procedures to reduce the spread while attending the conference. I attest that: I am not experiencing any COVID-19 symptoms. I have not traveled to a highly impacted area within the United States, nor have I traveled internationally within the last 14 days. I do not believe that I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19 variant. If I have tested positive for COVID-19 or have been in contact with someone with COVID-19 in the previous seven days before the first date of my arrival to the conference, I will not attend the SIDM2022 Annual Meeting. I am following CDC-recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

I am aware that the agreement includes a waiver, release of liability, and agreement by me to hold harmless the released parties. I have carefully read this agreement and fully understand its contents. I have had an opportunity to consult with an attorney concerning its contents.
